Dates:	Registration – 12 th April 2019. Fishing 13 th April 2019. Spare Weather Day – Sunday, 14 th April.
Venue:	PEDSAC – Port Elizabeth Harbour
Line Class:	Open Class – IGFA Rules apply.
Representation:	Fully paid and entered anglers only. The organising committee can assist in finding local boat owners to accommodate individuals if required.
Rules:	Rules and regulations will be posted on our website and supplied to all participants on day of registration.
Registration:	Registration will take place at the PEDSAC clubhouse on the 12 th April 2019 between 17:00 and 19:00. All anglers must register and complete indemnity forms.
Briefing:	A mandatory skippers briefing will take place at the PEDSAC clubhouse on the 12th April 2019 at 19h00. Dress code: Casual.
Prize Giving:	Will take place at the Venue / PEDSAC Club House on the 13th April 2019 at 18h00 or alternatively on Sunday, 13th April 2019 starting at 17:30 if Saturday is blown out. Dress code: Casual.
It is mandatory that all teams are present at these two functions	
Daily weigh-in:	Scales will open between 15h00 and 17h00 each day or otherwise as agreed and confirmed by the Adjudicating Committee.

Entry fees:	R150-00 per person. (No goodie bags to keep entries affordable) All accommodation, food / meals, fuel and bait for your own account. We can put entrants in touch with local boat owners for those who do not want to transport their boats from out of town. Please contact us well in advance.
